Our Commitment

Local Government Professionals Australia, SA is committed to protecting and safeguarding the privacy and confidentiality of your personal information.


Collection Statement

LG Professionals SA collect and keep on file information that is necessary to ensure that we are providing our services at the highest possible quality and providing our members and associates with a vast range of valuable information and services. No personal information is collected by browsing our website until you book into an event or program, log-on as a member, subscribe to our mailing list or place an enquiry via our website.

Information that is collected is stored for as long as it is needed to provide you with our services and keep you updated on relevant news, events, membership benefits, professional development services and all other services provided by us or our partners. Once your personal information is no longer needed by LG Professionals SA, we will destroy and delete it from our database.

Members Only

Your details may be shared with others (including other members) in the provision of these services and in the recruitment of new members. The constitution of LG Professionals SA, requires us to maintain a members' register. Your name, contact details, date of membership and membership category will be inserted into the members register. A member may view this register for the purpose of obtaining contact details so as to call a special general meeting. A member may not use the register for other extraneous purposes, for example, to obtain contact details so as to market a product or service. If you do not provide full details our services to you may be limited.

Use and Disclosure of Information

The key purpose of collecting your information is to ensure that we are fulfilling our commitments to you and providing you with adequate services that will assist us in assisting you.

Information given to LG Professionals SA about you or your organisation will only be used for the purpose in which it was given.

LG Professionals SA will occasionally enter contractual agreements with other companies to ensure that we are providing our members and associates with maximum benefits, however only your name, position, organisation and email will ever be disclosed to these third parties unless permission has been given by you to provide them with additional information.

Security of Personal Information


LG Professionals SA will use every means necessary to ensure that the personal information you provide is only given in a protected environment and is destroyed adequately once you cease your membership/relationship with LG Professionals SA or the information is no longer needed.

Financial information such as credit card details or bank details are stored securely for as long as they are required according to our auditors. They are destroyed once used for their designated purpose.

Employees of LG Professionals SA have limited access to your personal information and have all signed a confidentiality agreement upon commencement of employment. LG Professionals SA does not in any way hand out or sell your personal information to third parties except for third party providers and event sponsors.

In addition, please ensure that your personal password and login details for the LG Professionals SA website are kept private and confidential to ensure that no one can log in and extract your personal details.
